#### Why is it important to get a flu shot?

Getting your flu shot every year is the best way to help protect against the flu. It also lowers your risk of getting very sick.

Most people ages six months or older should get a flu shot. Talk to your provider to make sure you are up to date on all of your recommended vaccinations.

### Neighborhood members can get a no-cost flu shot at:

- Your provider's office
- A pharmacy such as Walgreens or CVS
- Local flu shot clinics

\*\*\*Some benefits mentioned are part of a special supplemental program for the chronically ill. You may qualify for coverage if you have a chronic condition including but not limited to hypertension, diabetes, chronic pulmonary disease, severe hematologic-rare genetic disorders, and depression. Additional eligibility criteria apply. Please contact us for full details.
