

Custodial Care Authorization Update for **INTEGRITY for Duals** Members

Neighborhood News – January 2026

Neighborhood Health Plan of Rhode Island (Neighborhood) is notifying Skilled Nursing Facilities (SNFs) of an important change related to custodial care coverage for **INTEGRITY for Duals (HMO D-SNP)** members.

Beginning January 1, 2026, Neighborhood **will only issue a 30-day custodial care authorization** for **INTEGRITY for Duals** members who do not have an approved [Long-Term Services and Supports \(LTSS\) waiver](#).

This change aligns Neighborhood with new state Dual Special Needs Plans (D-SNP) requirements.

What SNFs Need to Know

- **Initial custodial care authorizations will be limited to 30 days**

Starting January 1, if a member does not have an approved LTSS waiver at the time of SNF admission or at the time of the request, Neighborhood will issue a maximum of 30 days of custodial care coverage.

- **This change begins as of January 1, but the earliest member impact is February 1, 2026.**

Because the 30-day authorization period begins on the date the request is approved, the first potential denials for stays beyond 30 days would not occur until **February 1, 2026**.

- **After 30 days, an approved LTSS waiver is required for continued coverage**

Coverage beyond day 30 requires that the member has an approved [LTSS waiver](#) from the State.

Neighborhood recognizes that waiver applications may be submitted during a member's SNF stay and may be approved after day 30. If the State retroactively approves the LTSS waiver, please promptly submit the below documents to Neighborhood via fax to **401-459-6023** for authorization approval.

1. [A copy of the completed prior authorization form](#) and
2. The state-approved waiver letter

Appealing an Authorization Denial

[To submit an appeal on the member's behalf](#), the SNF must:

- Have documentation that the LTSS waiver has been approved by the State, and
- Have a valid **Appointment of Representative (AOR)** for the member on file.

Without a valid AOR, Neighborhood cannot process an appeal submitted by the facility. SNFs are strongly encouraged to obtain an AOR early in the member's stay. Appeals must be submitted within **65 days** of the denial and will be reviewed based on the waiver's retroactive effective date.

Additional Support and Outreach

Neighborhood's Care Management team will help support impacted members and facilities by:

- Reinforcing the importance of LTSS waiver submission,
- Providing education on the change, and
- Assisting with coordination related to member needs while the waiver is pending.
