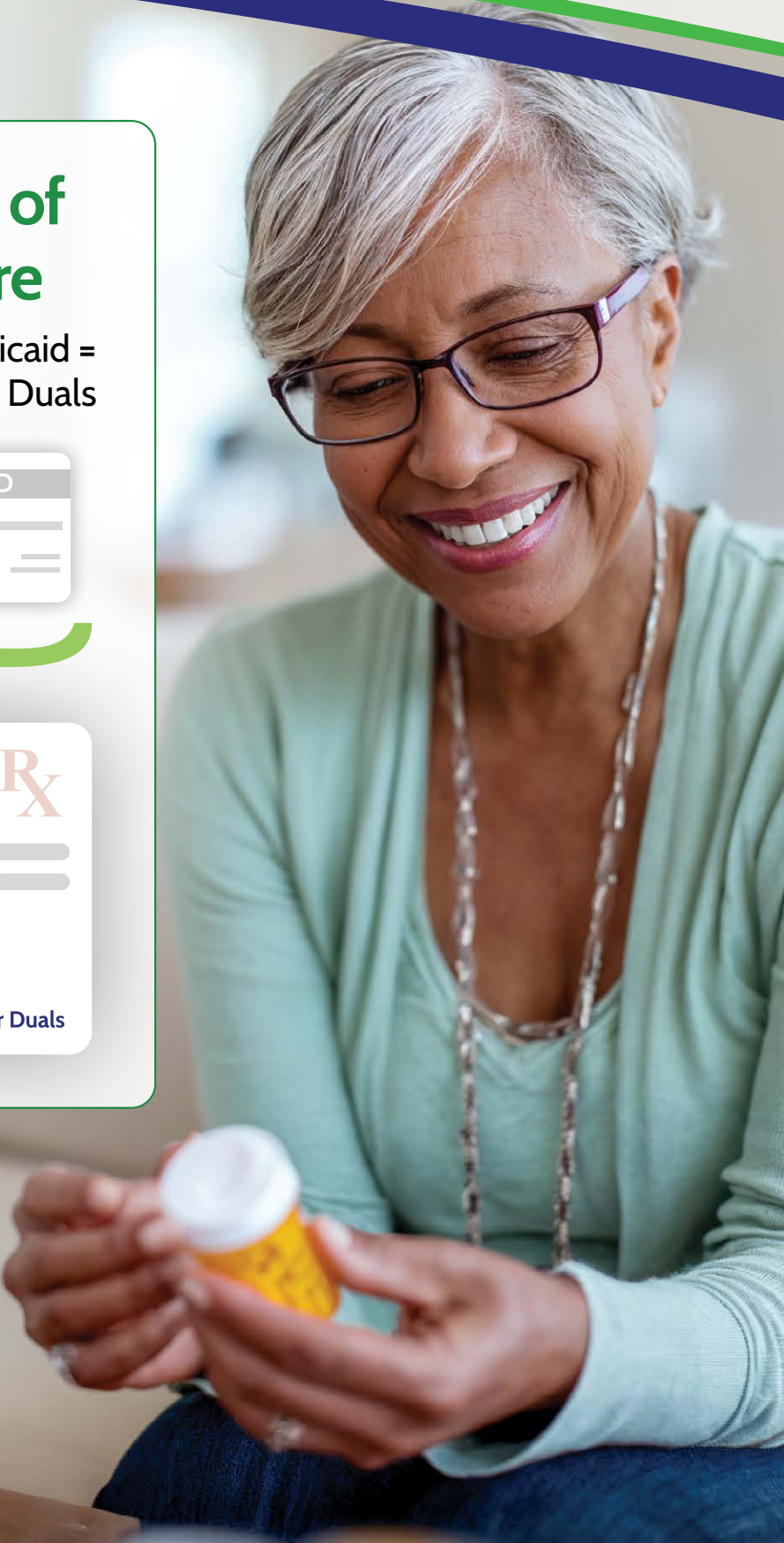
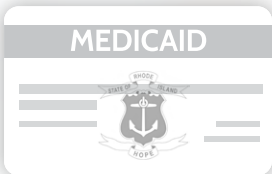
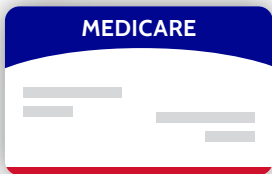

INTEGRITY for Duals members may be eligible for up to **\$153 each month with the Neighborhood &more card.**³ Use this card to shop for healthy food, over-the-counter (OTC), and wellness products.

Plus, members can get up to **\$65 each year** for healthy behaviors like going to your annual check-up and certain diabetic screenings.

Here's how it works:

1

All members will receive \$28 each month to spend on OTC and wellness products at stores like CVS, Walgreens, Walmart, and more. This includes personal care items like sunscreen and sleep aids, cold and flu medications, eye drops, allergy and sinus medications, first aid products, vitamins, and more.

2

Members may also be eligible for \$125 monthly³ to spend on healthy food and produce at local stores like Shaw's, Stop & Shop, Price Rite, Walmart, Dollar General, and many local markets near you.

3

Members can earn an additional \$65 for completing certain healthy behaviors like going to your annual check-up and completing certain diabetes health screenings.

Over-the-Counter (OTC) Medicines

There are two ways to get your OTC and wellness products

\$28 monthly deposit on your Neighborhood &more card to use on OTC and wellness products, including:

- » Sunscreen
- » Toothbrush and toothpaste
- » Vitamins and supplements
- » Sleep aids
- » Disposable briefs
- » First aid products

With a prescription from your provider, you can also get hundreds of generic OTC medicines⁴ with a **\$0** copay, including:

- » Allergy, sinus, cold and flu, and pain relief products
- » Smoking cessation products, like nicotine patches and gum
- » Digestive health products, like antacids and laxatives
- » Eye and ear care products, like eye drops and earwax removal drops
- » Skin care products, like healing ointment and dry skin cream



Durable Medical Equipment

You are eligible for durable medical equipment⁴ with a **\$0** copay, including:

- » Wheelchairs and walkers
- » Incontinence products
- » Crutches
- » Diabetic supplies
- » Oxygen equipment and supplies
- » Personal emergency response system

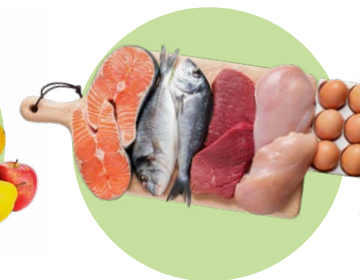

Long-Term Services and Supports (LTSS)

LTSS is a variety of services and supports that help you meet your daily needs. These services and supports can improve quality of life so that you can safely remain in your home, if you are eligible.⁹

Programs and services you may be eligible for with Neighborhood INTEGRITY for Duals' LTSS benefits:

Assisted living services¹⁰

- » Services and supports for you to live in an assisted living facility, such as help with meals; assistance with personal care; help with medications, housekeeping, and more

Home care services¹⁰

- » Personal care services, such as help with dressing and eating
- » Homemaking services, such as laundry and shopping

Home health agency care services¹¹

- » Full-time, part-time, or intermittent skilled nursing, certified nursing assistant, and home health aide services
- » Medical and social services
- » Medical equipment and supplies

Meals on Wheels

- » Food delivery to your home, including one meal per day for up to five days a week

Personal Choice Program

- » Choose a caregiver for the services you need, like personal care, homemaker services, and/or assistance with dressing and eating, so you can live at home
- » Using a budget based on your individual care needs, you can make the decisions on who provides the care you need

The plan may also pay for other services not listed here. If you get long-term services and supports (LTSS), you may have to pay part of the cost of the services. This amount is determined by Rhode Island Medicaid.

Need help at home?

You may be eligible for 120 hours of in-home support services in addition to any LTSS benefits you may be receiving.³

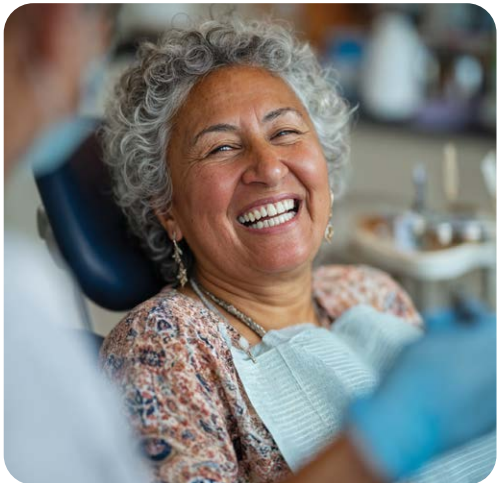
DELTA DENTAL[®] Dental Services

Neighborhood gives you something to smile about!

Neighborhood has partnered with Delta Dental of Rhode Island to offer preventive and restorative dental services up to \$1,250 per year.¹²

Members have access to these dental services in Rhode Island using Delta Dental of Rhode Island's Medicare Advantage Network.

- » Two (2) cleanings
 - » One (1) oral exam
 - » One (1) fluoride treatment
 - » Dental X-rays once per calendar year
 - » Fillings
 - » Denture repairs as needed
- » Extractions
 - » Root canals
 - » Recementing crowns or bridges once every 60 months
 - » Two (2) palliative pain treatments

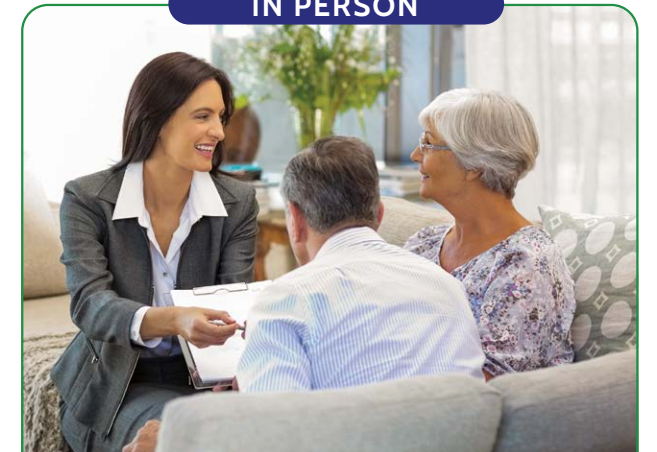

From April 1 through September 30, you can call us 8:00 a.m. to 8:00 p.m. Monday through Friday. You may leave a voicemail on Saturdays, Sundays, and federal holidays.



Neighborhood Health Plan of Rhode Island's INTEGRITY for Duals (HMO D-SNP) is a health plan that contracts with Medicare and the Rhode Island Medicaid Program. Enrollment in Neighborhood Health Plan of Rhode Island's INTEGRITY for Duals plan depends on contract renewal.

This is not a complete list of benefits. The benefit information is a brief summary, not a complete description of benefits. For more information, contact the plan or read the Neighborhood INTEGRITY for Duals Member Handbook.

Endnotes

- 1 Certain Medicaid benefits will still be covered through Rhode Island Medicaid, such as transportation services. We can help you access those services.
- 2 If you get long-term services and supports (LTSS), you may have to pay part of the cost of the services. This amount is determined by Rhode Island Medicaid.
- 3 The benefits mentioned are part of a special supplemental program for the chronically ill. You may qualify for coverage if you have a chronic condition including but not limited to hypertension, diabetes, chronic pulmonary disease, severe hematologic-rare genetic disorders, and depression. Additional eligibility criteria apply. Please contact us for full details.
- 4 Restrictions and limitations may apply. Prior authorization may be required.
- 5 Dental coverage though Neighborhood includes an annual \$1,250 limit for various preventive and restorative services. See page 17 for details. Neighborhood will assist with coordinating other services with Rhode Island Medicaid.
- 6 Covered by Rhode Island Medicaid.
- 7 If you get long-term services and supports (LTSS), you may have to pay part of the cost of the services. This amount is determined by Rhode Island Medicaid.
- 8 Restrictions may apply.
- 9 Eligibility is determined by Rhode Island Medicaid.
