

Updates to Patient Responsibility Information on the RA/EOP

Neighborhood News – July 2026

Neighborhood has received feedback from providers regarding how patient responsibility amounts are displayed on the Remittance Advice/Explanation of Payment (RA/EOP), particularly for members who are eligible for both Medicare and Medicaid.

To improve clarity, Neighborhood has updated the RA/EOP format to display Medicare and Medicaid co-payment and coinsurance amounts in separate columns.

The updated RA/EOP will include dedicated columns for:

- **Medicare Copay / Coinsurance**
- **Medicaid Copay / Coinsurance**

This enhancement is intended to help providers more easily identify and understand how cost-sharing amounts are reflected on the RA/EOP.

Please note that this is a formatting change only. It does not affect claim adjudication, reimbursement, or member cost-sharing requirements.

For **INTEGRITY for Duals** claims, the RA/EOP will also include an informational message near the plan name reminding providers that INTEGRITY for Duals members **are not responsible** for Medicare co-payments or coinsurance amounts, except during a member's deeming period.

Providers who receive paper RA/EOPs may also notice a new cover page. Because the RA/EOP detail pages are being updated to a landscape format, a portrait cover page has been added to help ensure the mailing address displays correctly in a window envelope. This cover page does not change the payment information included in the RA/EOP.

Neighborhood appreciates the feedback providers have shared and will continue working to make RA/EOP information clearer and easier to use.
