The CPT II codes are supplemental tracking codes that provide important information about a person's health and helps to close the gap in care.

Benefits of using CPT II Codes

- \checkmark Provides valuable information such as test results and lab values.
- ✓ Reduces the need for chart review and medical record abstraction.
- ✓ Streamlines data collection and attestation process.

CPT II codes provide important information for several measures including, but not limited to:

- Blood Pressure Control
- Care for Older Adults
- Diabetic Eye Exam
- Diabetic Testing
- Prenatal and Postpartum Care
