

Pharmacy Webpage Restructuring

Neighborhood’s Pharmacy Department is excited to announce a restructuring of the Provider Resources Pharmacy webpage. The new design will make it easier to find important information and distinguish resources based on the line of business.

When visiting the new Provider Resources Pharmacy webpage, you will initially be directed to a page with three categories. (See **Figure 1**)

The first option, **Formularies and Preferred Drug Lists**, will bring you to a landing page that contains Formularies (PDF and Searchable) and additional formulary specific resources separated by line of business. (See **Figure 2**) You can return to the main Pharmacy webpage at any time by simply selecting “[Click here to get back to the main Pharmacy page](#)”.

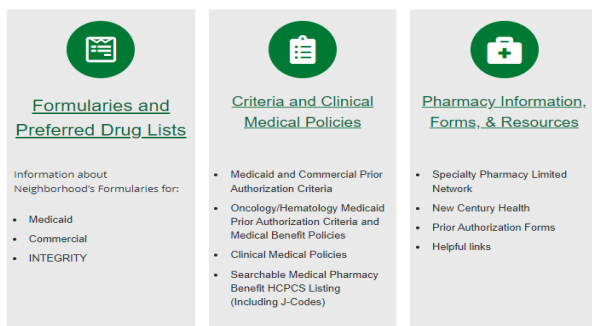
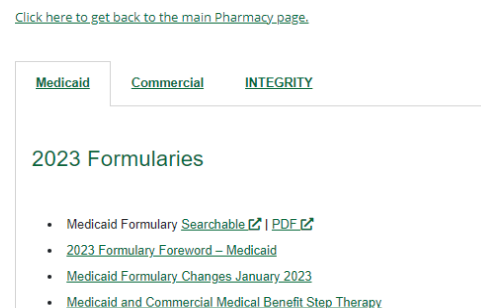

The second option, **Criteria and Clinical Medical Policies**, will bring you to a landing page where you can find all of Neighborhood’s Medicaid and Commercial Pharmacy Benefit Prior Authorization Criteria and Pharmacy Medical Benefit Clinical Medical Policies, including Oncology and Hematology criteria. Additionally, there will be a link to quickly get to the Medical Pharmacy Benefit Searchable HCPCS Code Listing (J-code Listing) (See **Figure 3**).
