

Upcoming Pharmacy Medical Benefit Preferred Therapy Changes

Neighborhood News - October 2023

Effective November 1, 2023, Neighborhood Health Plan of Rhode Island will recommend the following products under the Pharmacy Medical Benefit:

- Bortezomib
 - o J9041, Injection, bortezomib, 0.1 mg
- Pemetrexed
 - o J9297, Injection, pemetrexed (sandoz), not therapeutically equivalent to J9305, 10mg
- Fulvestrant
 - o J9394, Injection, fulvestrant (fresenius kabi) not therapeutically equivalent to J9395, 25 mg

The preference for these products only applies to members who are **not** currently being administered bortezomib, pemetrexed, or fulvestrant. Members already on these treatments can continue with their current regimen.
