## Children's Care Services Payment Policy

---

### Policy Statement

Children's Care Services involve the diagnosis and treatment of children's health and wellbeing, a comprehensive set of services including routine office visits, preventative care, and screenings are covered.

Pediatric preventive care coverage is provided in accordance with the American Academy of Pediatrics guidelines and as required by Rhode Island General Laws Section § 27-38.1.

### Scope

This policy applies to:

**Medicaid** *excluding Extended Family Planning (EFP), Rbody Health Partners (RHP), Rbody Health Partners Expansion (RHE)*

### Prerequisites

All services must be medically necessary to qualify for reimbursement. Neighborhood may use the following criteria to determine medical necessity:

- National Coverage Determination (NCD)
- Local Coverage Determination (LCD)
- Industry accepted criteria such as InterQual
- Rhode Island Executive Office of Health and Human Services (EOHHS) recommendations
- Clinical Medical Policies (CMP)

It is the provider's responsibility to verify eligibility, coverage and authorization criteria prior to rendering services.

### Coverage Includes

- Prenatal pediatric office visit
- Pediatric preventative care visits including well-child check-ups, routine visits, and sick visits
- Pediatric Screenings
- Fluoride varnish



- Early intervention services, rendered by an EI provider, for qualified children from birth up to age 3 years who are experiencing developmental delays.
- Pediatric development and autism screening
- Ocular Photoscreening

### **Pediatric COVID vaccine counseling**

Neighborhood will temporarily cover and separately reimburse for pediatric COVID vaccine counseling:

- Must be provided on the same day as a scheduled preventive or sick visit
- May be billed once (or 1 unit) for each individual member
- Must be billed with CPT code 99401, 99402, 99403, or 99404 and modifier CR and modifier 25
- Member cost sharing is waived for this counseling service\*

\*NOTE: Cost sharing may apply to the office visit code if applicable

School based health centers may provide both well and sick visits as well as immunizations, chronic care visits like asthma and diabetes, and physicals. Episodes of care can occur across multiple settings; the following are included in the detailed benefit service category criteria:

Episodes of care can occur across multiple settings:

- School (POS 03)
- Office (POS 11)
- Home (POS 12)
- Urgent Care Facility (POS 20)
- Outpatient (POS 22)
- Federally Qualified Health Center (POS 50)

### **Coverage Limitations**

- Early Intervention services are rendered by state certified providers for qualified members up to age 3.
- Fluoride varnish service is limited to member's age 6 months to 18.99 years and rendered by the member's PCP or covering practitioner. There is an annual limit of 4 units per calendar year.
- CRAFFT Screening (Substance use in adolescence) limited to 1 unit per calendar year for ages 11-21 years.
- Pediatric Development Screening service is limited to 5 services up to age 3 rendered by the member's PCP or covering practitioner.
- Pediatric Autism Screening service is limited to 5 services up to age 3 rendered by the members PCP or covering practitioner.
- Pediatric Development or Autism Screening is limited to 1 per year for members age 3 to 21 and rendered by the members PCP or covering practitioner.



- Ocular Photoscreening is limited to member ages 6 months up to 5 years without authorization. Age 5 years and older require authorization.
- School based health centers services are limited per regulatory requirements. Services are provided to children greater than 11 and up to age 21 (pre-adolescent through adult) covering age ranges for middle school/high school. Neighborhood covers PCP services provided at school based health centers as appropriate to that setting.
- Prenatal pediatric visit is limited to no more than 2 visits, up to 30 minutes per visit.
- Pediatric COVID counseling is limited to children up to and including the age of 21 years.

### Exclusions

- Routine dental care is not covered for Medicaid members. For children born on or after May 1, 2000 who are RIte Care eligible, refer to the RIte Smiles program for coverage.
- Vision screening (CPT codes 99172, 99173) and hearing screening (CPT codes 92551) are part of the routine pediatric visit and are not separately billable.
- Pediatric COVID counseling is not covered for members with no scheduled office visit for that day.

### Claim Submission

**Newborns** – Neighborhood will accept claims submitted under the mother’s member ID number for the first 30 days of a newborn’s life. After 30 days, claims should be submitted under the newborn’s member ID number.

Billable services are subject to contractual agreements, when applicable. Providers are required to submit complete claims for payment within contractually determined timely filing guidelines.

Coding must meet standards defined by the American Medical Association’s Current Procedural Terminology Editorial Panel’s (CPT®) codebook, the International Statistical Classification of Diseases and Related Health Problems, 10th revision, Clinical Modification (ICD-10-CM), and the Healthcare Common Procedure Coding System (HCPCS) Level II.

### Documentation Requirements

Neighborhood reserves the right to request medical records for any service billed. Documentation in the medical record must support the service(s) billed as well as the medical necessity of the service(s). Neighborhood follows CMS standards for proper documentation requirements.

### Member Responsibility

**Commercial** plans include cost sharing provisions for coinsurance, copays, and deductibles. Members may have out of pocket expenses based on individual plan selection and utilization. Please review cost sharing obligations or contact Member Services prior to finalizing member charges.

**Coding**

The inclusion of a code in this policy does not guarantee coverage or reimbursement.

Typically, 20 minutes are spent face-to-face with the patient and/or family.
<b>97162</b>	Physical therapy evaluation: low complexity, requiring these components: A history with no personal factors and/or comorbidities that impact the plan of care; An examination of body system(s) using standardized tests and measures addressing 1-2 elements from any of the following: body structures and functions, activity limitations, and/or participation restrictions; A clinical presentation with stable and/or uncomplicated characteristics; and Clinical decision making of low complexity using standardized patient assessment instrument and/or measurable assessment of functional outcome. Typically, 20 minutes are spent face-to-face with the patient and/or family.

<b>97163</b>	Physical therapy evaluation: high complexity, requiring these components: A history of present problem with 3 or more personal factors and/or comorbidities that impact the plan of care; An examination of body systems using standardized tests and measures addressing a total of 4 or more elements from any of the following: body structures and functions, activity limitations, and/or participation restrictions; A clinical presentation with unstable and unpredictable characteristics; and Clinical decision making of high complexity using standardized patient assessment instrument and/or measurable assessment of functional outcome. Typically, 45 minutes are spent face-to-face with the patient and/or family.
<b>97164</b>	Re-evaluation of physical therapy established plan of care, requiring these components: An examination including a review of history and use of standardized tests and measures is required; and Revised plan of care using a standardized patient assessment instrument and/or measurable assessment of functional outcome Typically, 20 minutes are spent face-to-face with the patient and/or family.
<b>97165</b>	Occupational therapy evaluation, low complexity, requiring these components: An occupational profile and medical and therapy history, which includes a brief history including review of medical and/or therapy records relating to the presenting problem; An assessment(s) that identifies 1-3 performance deficits (ie, relating to physical, cognitive, or psychosocial skills) that result in activity limitations and/or participation restrictions; and Clinical decision making of low complexity, which includes an analysis of the occupational profile, analysis of data from problem-focused assessment(s), and consideration of a limited number of treatment options. Patient presents with no comorbidities that affect occupational performance. Modification of tasks or assistance (eg, physical or verbal) with assessment(s) is not necessary to enable completion of evaluation component. Typically, 30 minutes are spent face-to-face with the patient and/or family.
<b>97166</b>	Occupational therapy evaluation, moderate complexity, requiring these components: An occupational profile and medical and therapy history, which includes an expanded review of medical and/or therapy records and additional review of physical, cognitive, or psychosocial history related to current functional performance; An assessment(s) that identifies 3-5 performance deficits (ie, relating to physical, cognitive, or psychosocial skills) that result in activity limitations and/or participation restrictions; and Clinical decision making of moderate analytic complexity, which includes an analysis of the occupational profile, analysis of data from detailed assessment(s), and consideration of several treatment options. Patient may present with comorbidities that affect occupational performance. Minimal to moderate modification of tasks or assistance (eg, physical or verbal) with assessment(s) is necessary to enable patient to complete evaluation component. Typically, 45 minutes are spent face-to-face with the patient and/or family.

<b>97167</b>	Occupational therapy evaluation, high complexity, requiring these components: An occupational profile and medical and therapy history, which includes review of medical and/or therapy records and extensive additional review of physical, cognitive, or psychosocial history related to current functional performance; An assessment(s) that identifies 5 or more performance deficits (ie, relating to physical, cognitive, or psychosocial skills) that result in activity limitations and/or participation restrictions; and Clinical decision making of high analytic complexity, which includes an analysis of the patient profile, analysis of data from comprehensive assessment(s), and consideration of multiple treatment options. Patient presents with comorbidities that affect occupational performance. Significant modification of tasks or assistance (eg, physical or verbal) with assessment(s) is necessary to enable patient to complete evaluation component. Typically, 60 minutes are spent face-to-face with the patient and/or family.
<b>97168</b>	Re-evaluation of occupational therapy established plan of care, requiring these components: An assessment of changes in patient functional or medical status with revised plan of care; An update to the initial occupational profile to reflect changes in condition or environment that affect future interventions and/or goals; and A revised plan of care. A formal reevaluation is performed when there is a documented change in functional status or a significant change to the plan of care is required. Typically, 30 minutes are spent face-to-face with the patient and/or family.
<b>99174</b>	Instrument-based ocular screening (eg, photoscreening, automated-refraction), bilateral; with remote analysis and report
<b>99177</b>	Instrument-based ocular screening (eg, photoscreening, automated-refraction), bilateral; with on-site analysis
<b>99188</b>	Application of topical fluoride varnish by a physician or other qualified health care professional
<b>99202</b>	Office or other outpatient visit for the evaluation and management of a new patient, which requires a medically appropriate history and/or examination and straightforward medical decision making. When using time for code selection, 15-29 minutes of total time is spent on the date of the encounter.
<b>99203</b>	Office or other outpatient visit for the evaluation and management of a new patient, which requires a medically appropriate history and/or examination and low level of medical decision making. When using time for code selection, 30-44 minutes of total time is spent on the date of the encounter.
<b>99204</b>	Office or other outpatient visit for the evaluation and management of a new patient, which requires a medically appropriate history and/or examination and moderate level of medical decision making. When using time for code selection, 45-59 minutes of total time is spent on the date of the encounter.

<b>99205</b>	Office or other outpatient visit for the evaluation and management of a new patient, which requires a medically appropriate history and/or examination and high level of medical decision making. When using time for code selection, 60-74 minutes of total time is spent on the date of the encounter.
<b>99211</b>	Office or other outpatient visit for the evaluation and management of an established patient, that may not require the presence of a physician or other qualified health care professional. Usually, the presenting problem(s) are minimal.
<b>99212</b>	Office or other outpatient visit for the evaluation and management of an established patient, which requires a medically appropriate history and/or examination and straightforward medical decision making. When using time for code selection, 10-19 minutes of total time is spent on the date of the encounter.
<b>99213</b>	Office or other outpatient visit for the evaluation and management of an established patient, which requires a medically appropriate history and/or examination and low level of medical decision making. When using time for code selection, 20-29 minutes of total time is spent on the date of the encounter.
<b>99214</b>	Office or other outpatient visit for the evaluation and management of an established patient, which requires a medically appropriate history and/or examination and moderate level of medical decision making. When using time for code selection, 30-39 minutes of total time is spent on the date of the encounter.
<b>99215</b>	Office or other outpatient visit for the evaluation and management of an established patient, which requires a medically appropriate history and/or examination and high level of medical decision making. When using time for code selection, 40-54 minutes of total time is spent on the date of the encounter.
<b>99381</b>	Initial comprehensive preventive medicine evaluation and management of an individual including an age and gender appropriate history, examination, counseling/anticipatory guidance/risk factor reduction interventions, and the ordering of laboratory/diagnostic procedures, new patient; infant (age younger than 1 year)
<b>99382</b>	Initial comprehensive preventive medicine evaluation and management of an individual including an age and gender appropriate history, examination, counseling/anticipatory guidance/risk factor reduction interventions, and the ordering of laboratory/diagnostic procedures, new patient; early childhood (age 1 through 4 years)
<b>99383</b>	Initial comprehensive preventive medicine evaluation and management of an individual including an age and gender appropriate history, examination, counseling/anticipatory guidance/risk factor reduction interventions, and the

	ordering of laboratory/diagnostic procedures, new patient; late childhood (age 5 through 11 years)
<b>99384</b>	Initial comprehensive preventive medicine evaluation and management of an individual including an age and gender appropriate history, examination, counseling/anticipatory guidance/risk factor reduction interventions, and the ordering of laboratory/diagnostic procedures, new patient; adolescent (age 12 through 17 years)

<b>99391</b>	Periodic comprehensive preventive medicine reevaluation and management of an individual including an age and gender appropriate history, examination, counseling/anticipatory guidance/risk factor reduction interventions, and the ordering of laboratory/diagnostic procedures, established patient; infant (age younger than 1 year)
